#### Terms and Conditions for Obtaining a Stability Certificate for Puja Pandal

#### 1. Submission of Application

The Puja Committee must submit a formal application to the municipality requesting a stability certificate at least \_\_\_\_\_\_ days prior to the event. The application should include all necessary documents.

- 2. Structural Drawings and Design The Puja Committee must provide detailed structural drawings and design plans of the pandal, verified and approved by a certified structural engineer/LBS. The design must adhere to local building codes and safety standards.

0	Fire Safety: Adequate fire safety measures, including fire extinguishers, sand
	buckets, and water sources, must be installed.

- Electrical Safety: All electrical installations must be done by licensed electricians and comply with safety norms, ensuring proper earthing and insulation to avoid short circuits and fires.
- **Emergency Exits:** The pandal must have clearly marked emergency exits and accessible pathways for smooth crowd movement in case of an emergency.

#### 4. Load-Bearing Capacity

The structure must be capable of withstanding environmental factors, such as wind and rain. The Puja Committee should ensure that the materials used for construction (bamboo, cloth, metal, etc.) are of high quality and can sustain the expected crowd load.

#### 5. Crowd Management Plan

The Puja Committee must present a crowd management plan, which includes provisions for managing large gatherings, proper queuing systems, and security personnel to ensure smooth entry and exit.

#### 6. Site Inspection

The Puja pandal site must be accessible for inspection by the municipality engineer and other authorities. The Puja Committee should cooperate during site visits and provide necessary information as requested by the inspecting officials.

#### 7. Insurance Coverage

The Puja Committee must ensure the pandal and event are covered by adequate public liability insurance to address any unforeseen incidents or accidents during the festival.

## 8. NOC from Fire and Police Departments

Before applying for the stability certificate, the Puja Committee must obtain No Objection Certificates (NOCs) from the Fire Department and the local Police Station. These documents must confirm that fire safety, crowd control, and emergency protocols are in place.

## 9. Environmental and Noise Regulations

The pandal must comply with environmental regulations, including restrictions on sound levels (as per the local municipality's noise pollution guidelines) and proper waste management during and after the festival.

## 10. Responsibility for Maintenance

The Puja Committee will be responsible for the regular maintenance and upkeep of the pandal throughout the festival period to ensure safety. Any structural damage or concerns raised by authorities must be addressed immediately.

## 11. Adherence to Local Guidelines

The Puja Committee must follow all additional guidelines or instructions issued by the local municipal authority. Any violation of these terms can lead to the cancellation of the stability certificate.

- 10. Crowd management and fire safety plan
- 11. Environmental clearance (if applicable)
